LCRA-OSSF Resolution

RESOLUTION NO. 2003-R-06

A RESOLUTION AUTHORIZING THE LOWER COLORADO RIVER AUTHORITY TO REGULATE ALL ON-SITE SEWAGE FACILITIES WITHIN THE CORPORATE LIMITS OF VOLENTE, TEXAS.

WHEREAS, the Village of Volente, Texas was incorporated as a Type B General Law Municipality pursuant to Texas Local Government Code Chapter 7 on February 18, 2003 and its corporate limits include areas not regulated by the Lower Colorado River Authority (LCRA) for on-site sewage facilities; and

WHEREAS, LCRA is an authorized agent of the Texas Commission on Environmental Quality (TCEQ) for the regulation of on-site sewage facilities around the Highland Lakes of the Colorado River, Texas [Tex. Health & Safety Code § 366 (West 2002)]; and

WHEREAS, LCRA has the authority to include in its Rules for On-Site Sewage Facilities the corporate limits of the Village of Volente, Texas; and

WHEREAS, the City Council of Volente has determined that it would be more cost efficient and the public would be better served if LCRA directly regulates all on-site sewage facilities within the corporate limits of Volente, Texas;

NOW, THEREFORE, BE IT RESOLVED that the City Council of Volente requests LCRA do all things necessary to amend its Rules for On-Site Sewage Facilities and become the authorized agent for the regulation of on-site sewage facilities within the entire corporate limits of Volente, Texas; and

BE IT FURTHER RESOLVED that:

1. the City Council of Volente requests the TCEQ designate LCRA as the authorized agent for the regulation of on-site sewage facilities within the corporate limits of Volente, Texas; and
2. LCRA is requested to consult with the City Council regarding OSSF rule amendments that are proposed for application in Volente; and
3. LCRA is requested to confer with the City Council regarding all applications for variances under the OSSF rules in Volente.
