

RESOLUTION NO. 2004-R-13

A RESOLUTION OF THE VILLAGE OF VOLENTE, TEXAS, ORDERING A REGULAR VILLAGE OFFICER'S ELECTION TO BE HELD ON THE 15TH DAY OF MAY, 2004; DESIGNATING THE POLLING PLACES AND APPOINTING ELECTION OFFICIALS FOR SUCH ELECTION; DIRECTING THE GIVING OF NOTICE OF SUCH ELECTION; AND PROVIDING DETAILS RELATING TO THE HOLDING OF SUCH ELECTION

BE IT RESOLVED BY THE CITY COUNCIL OF THE VILLAGE OF VOLENTE, TEXAS:

Section 1: It is hereby ordered that a Regular Election be held in the Village of Volente on the 15th day of May, 2004, at which election the following officers shall be elected by the qualified voters of the Village:

MAYOR

ALL FIVE CITY COUNCIL MEMBER POSITIONS

Section 2: That, as per an Interlocal Agreement with Travis County, Texas pursuant to Chapter 271 of the Texas Election Code and Chapter 791 of the Texas Government Code, this election shall be combined with the Travis County election to be held on the same date.


Section 3: The boundaries of the Village constituting one election precinct, the polls shall be open for voting from seven o'clock (7:00) a.m. until seven o'clock (7:00) p.m. at the polling place(s) to be determined by Travis County. Additionally, Travis County shall appoint the election officials to conduct the election at said polling place.

Section 4: The City Clerk is hereby appointed as the regular early voting clerk and the custodian of records for the Village, and shall perform the duties in accordance with the Interlocal Agreement with Travis County, Texas to conduct the joint election. The Travis County Clerk is hereby appointed as the joint early voting clerk. Early voting shall be conducted jointly, and the Travis County Airport Boulevard Offices, 5501 Airport Boulevard, Austin, Texas is hereby designated as the main early voting polling place for early voting for such election. Early voting shall be conducted at said location from seven o'clock (7:00) a.m. until seven o'clock (7:00) p.m., Monday through Saturday, and from noon (12:00) p.m. until six o'clock (6:00) p.m. on Sunday, on each day for early voting which is not an official state holiday, beginning on the seventeenth (17th) day and continuing through the fourth (4th) day preceding the date of such election. Early voting for said election shall also be conducted at the branch early voting polling places on the dates and during the times described in Exhibit "A" attached hereto and incorporated herein.

Section 5: The City Clerk is hereby authorized and directed to furnish all necessary election supplies to conduct such election, and to generally care for and arrange all details of said election, subject to the Interlocal Agreement with Travis County, Texas regarding said joint election.

Section 6: Notice of this election shall be given in accordance with the provisions of the Texas Election Code and returns of such notice shall be made as provided for in said Code. The Mayor shall issue all necessary orders and writs for such election, and returns of such election shall be made to the City Clerk after the closing of the polls.


