**ORDINANCE NO. 2003-O-09**

**AN ORDINANCE OF THE VILLAGE OF VOLENTE, TEXAS REPEALING ITS ELECTION ORDER OF JULY 15, 2003 THAT CALLED A SPECIAL ELECTION FOR NOVEMBER 4, 2003 ON THE PROPOSITIONS OF ADOPTING A ONE PERCENT MUNICIPAL SALES AND USE TAX, WITHDRAWING FROM THE CAPITAL METROPOLITAN TRANSPORTATION AUTHORITY, AND ADOPTING A ONE-FOURTH OF ONE PERCENT SALES AND USE TAX FOR STREET MAINTENANCE PURPOSES, AND RELATED MATTERS**

**WHEREAS**, on July 15, 2003, the City Council of Volente, Texas approved an Election Order calling a special election for November 4, 2003 on the propositions of adopting a one percent municipal sales and use tax, withdrawing from the Capital Metropolitan Transportation Authority ("Capital Metro"), adopting a one-fourth of one percent sales and use tax for street maintenance purposes, and making provision for the conduct of the election and resolving other matters incident and relating to the holding of such election; and

**WHEREAS**, the City Council of Volente has determined that it is eligible to receive a one-fourth of one percent rebate of the one percent Capital Metro sales tax collected in the Village and is eligible to apply annually for an allocation from Capital Metro to be used for Village projects approved by Capital Metro; and

**WHEREAS**, the City Council of Volente has determined that it is in the best interests of the citizens of Volente to repeal the Election Order of July 15, 2003 in order to cancel the special election on the propositions of withdrawing from Capital Metro and adopting a one-fourth of one percent sales and use tax for street maintenance purposes, and to adopt a separate ordinance calling a special election for November 4, 2003 on the proposition of adopting a one percent municipal sales and use tax;

**NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE VILLAGE OF VOLENTE** that:

- (1) The Election Order of July 15, 2003 of the Village of Volente, Texas is hereby repealed in its entirety; and
- (2) City staff is directed to prepare an ordinance ordering an election for November 4, 2003 on the proposition of adopting a one percent municipal sales and use tax and making provision for the conduct of the election and resolving other matters incident and relating to the holding of such election.
