WHEREAS, the Village of Volente finds that the unclear numbering of Section 30.113, 30.114, 30.115, 30.120, 30.122 and 30.123 creates confusion in enforcing Article 30 Zoning Regulations,

Section 1. The recitals above made in the Preamble are hereby deemed to be the Factual and Legislative Findings of the Village Council, and are hereby incorporated within this Ordinance.

Section 30.113 is amended to add 30.113(e) (1) authorizing pumping plants as a conditional use in this zoning district.

Section 30.114 is amended to add 30.114(d) (1) authorizing pumping plants as a conditional use in this zoning district.

Section 30.115 is amended to add 30.115(d) (1) authorizing pumping plants as a conditional use in this zoning district.

Section 30.120 is amended to add 30.120 (b) (3) authorizing pumping plants as a conditional use in this zoning district.

Section 30.122 is amended to add 30.122 (a) (8) authorizing pumping plants as a conditional use in this zoning district.

Section 30.123 is amended to add 30.123 (a) (22) authorizing pumping plants as a conditional use in this zoning district.

47 **Section 3. Severability.**

49 If any provision of this Ordinance or the application of any provision to any person or circumstance
50 is held invalid, the invalidity shall not affect other provisions or applications of the ordinance
51 which can be given effect without the invalid provision or application, and to this end the
52 provisions of this Ordinance are declared to be severable.

56 This Ordinance shall take effect immediately from and after its passage, in conformance with law.

58 **Section 5. Compliance with Public Notice and Meeting Requirements.**
