Section 1. The Village of Volente Ordinance 2004-O-32 and Ordinance 2006-O-59 Article 30.110 Establishing of Zoning Districts is amended as follows:

The Village is hereby divided into thirteen (13) zoning districts, the use height and area regulations as set out herein shall be uniform in each district, except the PDD districts. The thirteen (13) districts established shall be known as:

Section 3. Addition to Article 30 of Section 124 (C) Planned Development District-PDD. This section created by Ordinance 2006-O-59 and miss-numbered Section 124 (A) shall now be numbered Section 124 (C).

If any provision of this Ordinance or the application of any provision to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.
