

**VILLAGE OF VOLENTE
ORDINANCE NO. 2021-O-2**

FISCAL YEAR 2019 BUDGET AMENDMENT

AN ORDINANCE OF THE VILLAGE OF VOLENTE, TEXAS AMENDING THE CURRENT 2018-2019 FISCAL YEAR BUDGET; FINDING MUNICIPAL PURPOSES; AUTHORIZING COMMITMENT OF FUNDS; PROVIDING FOR A REPEALER, CLAUSE, PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR NOTICE TO THE COUNTY; PROVIDING FOR CODIFICATION AND POSTING; PROVIDING FOR AN EFFECTIVE DATE; AND PROVIDING FOR PROPER NOTICE AND MEETING.

WHEREAS, the Village Council of the Village of Volente ("Village Council") seeks to amend and otherwise modify the Village's budget for Fiscal Year 2019; and

WHEREAS, the Village Council needs to authorize the transfer of funds to the Committed Fund for Road Maintenance; and

WHEREAS, pursuant to Texas Local Government Code Section 101.002, the Village Council may manage and control the finances of the municipality; and

WHEREAS, the Village Council finds that it is necessary and proper for the good governance to adopt an ordinance amending the 2019 budget.

NOW, THEREFORE, BE IT ORDAINED by the Volente Village Council, that:

1. BUDGET AMENDMENT

The Village Council hereby approves the following amendments to the municipal budget for fiscal year 2018-2019:

2. AUTHORIZE COMMITMENT OF FUNDS

The Village Council hereby approves the transfer of \$125,000 from the unassigned General Fund balance to the Committed Fund for Road Maintenance.

3. REPEALER

To the extent reasonably possible, ordinances are to be read together in harmony. However, all ordinances, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated, herein.

4. SEVERABILITY

Should any of the clauses, sentences, paragraphs, sections, or parts of this Ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Ordinance.

5. NOTICE TO COUNTY

The Village Secretary has hereby been directed to file this Budget Amendment in the office of the County Clerk in Travis County pursuant to Chapter 102 of the Local Government Code.

6. RECORDING AND POSTING

The Village Secretary has hereby been directed to record and publish the Budget Amendment in the Village's Code of Ordinances authorized by Section 52.001 of the Texas Local Government Code and to post this amended budget on the Village Website pursuant to Chapter 102 of the Local Government Code.

7. EFFECTIVE DATE


This Ordinance shall be effective immediately upon passage and publication as provided for by law.

8. PROPER NOTICE & MEETING


