**RESOLUTION NO: 2021-R-6**

**GENERAL ELECTION CANVASS OF RETURNS**

**A RESOLUTION OF THE VILLAGE COUNCIL OF THE VILLAGE OF VOLENTE, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION, HELD ON NOVEMBER 2, 2021, FOR THE PURPOSE OF ELECTING THREE (3) COUNCIL MEMBERS.**

**WHEREAS**, the Village Council ordered a General Election (Resolution No. 2021-R-3), to be held on the 2<sup>nd</sup> day of November 2021, for the purpose of electing a three (3) Council Members; and

**WHEREAS**, this election was duly and legally held on November 2, 2021, in conformity with the election laws of the State of Texas, and the results of the election have been certified and returned by the Travis County Elections Division; and

**WHEREAS**, section 67.003 of the Texas Election Code, as amended, generally provides that each local canvassing authority shall convene not later than the eleventh (11th) day after the election date for the purpose of canvassing the election results; and

**WHEREAS**, section 67.004(a) of the Texas Election Code, as amended, establishes the quorum level required to canvass election results and provides that two members of the canvassing authority constitute a quorum for purposes of canvassing the election; and

**WHEREAS**, it appears to the Council, and the Council finds, that the election was in all aspects lawfully held; and

**WHEREAS**, it appears to the Council, and the Council finds, that the tabulation of the results of the election are correct.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF VOLENTE, TEXAS, THAT:**

**SECTION 1.** The General Election of November 2, 2021, was duly called, notice of said election was given and was held in accordance with the law.

**SECTION 2.** The tabulation of votes cast in the General Election held on November 2, 2021, for the purpose of electing three (3) Village Council Members, a copy of which is attached to and made a part of this Resolution is adopted as the official tabulation of the votes cast at the election, and the tabulation will be filed and recorded in the official records of the Village of Volente, as the official canvass of the election.

**SECTION 3.** The official canvass of the returns of the election reflects the following:

For three (3) Council Member positions, the following candidates received votes as follows:

Timothy T. McMillan 117

Mary Scherer 93

Tom Blauvelt 142

**SECTION 4.** From said returns, the candidates receiving the most votes cast in said election, the following candidates are hereby duly elected as Council Members for the Village of Volente, Texas:

*Mark Metro*  
*Timothy T. McMillan*  
*Tom Blauvelt*

The above-named persons are hereby duly elected at said election and shall take their respective offices upon their qualification therefore, as provided by the laws of the State of Texas.

**SECTION 5.** The Mayor of the Village of Volente is authorized to execute and the Village Secretary is authorized to attest to this Resolution on behalf of the Village Council. The Mayor is further authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.

**SECTION 6.** This Resolution is effective immediately upon its passage and approval.

**SECTION 7.** A quorum of the Council was present at the meeting at which this Resolution was adopted. The meeting was open to the public and public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.
