**GENERAL ELECTION CANVASS OF RETURNS**

**A RESOLUTION OF THE COUNCIL OF THE VILLAGE OF VOLENTE, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION, HELD ON NOVEMBER 5, 2019, FOR THE PURPOSE OF ELECTING THREE (3) COUNCIL MEMBERS.**

**WHEREAS**, On August 16, 2019, the Village Council ordered a General Election, to be held on the 5<sup>th</sup> day of November 2019, for the purpose of electing three (3) Village Council Members; and

**WHEREAS**, Notice of this election was duly published in the Hill Country News on October 17, 2019, and a copy of the notice was posted at City Hall; and

**WHEREAS**, this election was duly and legally held on November 5, 2019, in conformity with the election laws of the State of Texas, and the results of the election have been certified and returned by the Travis County Elections Division; and

**WHEREAS**, it appears to the Council, and the Council finds, that the election was in all aspects lawfully held; and

**WHEREAS**, it appears to the Council, and the Council finds, that the tabulation of the results of the election are correct.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF VOLENTE, TEXAS TUAT:**

**SECTION 1.** The General Election of November 5, 2019 was duly called, notice of said election was given and was held in accordance with the law.

**SECTION 2.** The tabulation of votes cast in the General Election held on November 5, 2019, for the purpose of electing a three (3) Village Council Members, a copy of which is attached to and made a part of this ordinance is adopted as the official tabulation of the votes cast at the election, and the tabulation will be filed and recorded in the official records of the Village of Volente, as the official canvass of the election.

SECTION 3. The official canvass of the returns of the election reflects the following:

A. For three (3) Council Member positions, the following candidates received votes as follows:

SECTION 4. From said returns, the three (3) candidates receiving the most votes cast in said election, the following candidates are hereby duly elected as Council Members for the Village of Volente, Texas:

- ED RACHT
- ISABELLE EVANS
- CLAUDIA WILSON

The above-named persons are hereby duly elected at said election and shall take their respective offices upon their qualification therefore, as provided by the laws of the State of Texas.

SECTION 5. The Mayor of the Village of Volente is authorized to execute and the Village Secretary is authorized to attest to this Resolution on behalf of the Village Council. The Mayor is further authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.

SECTION 6. This Resolution is effective immediately upon its passage and approval.

SECTION 7. A quorum of the Council was present at the meeting at which this Resolution was adopted. The meeting was open to the public and public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.
